All in favor; motion passed.

Agreement and Conservation and Public Recreation Easement and Agreement under the Open Space and Watershed Land Acquisition Program with the State of Connecticut for financial assistance to acquire permanent interest in land known as Rita Edwards Preserve (Cedar Swamp Road) Hampton, OSWA-454 and to manage said land as open space land pursuant to Section 7-131d of the Connecticut General Statutes. All in favor; motion passed.

C. Resolution for FY 2011 State Homeland Security Grant Program

MOTION: Selectmen Grindle/ Chapel moved/ seconded to resolve that the Board of Selectmen may enter into with and deliver to the State of Connecticut Department of Emergency Management and Homeland Security any and all documents which it deems to be necessary or appropriate; and further resolved, that Allan Cahill, as First Selectman of the Board of Selectmen, is authorized and directed to execute and deliver any and all documents on behalf of the Board of Selectmen and to do and perform all acts and things which he deems to be necessary or appropriate to carry out the terms of such documents, including, but not limited to, executing and delivering all agreements and documents contemplated by such documents. All in favor; motion passed.

D. Discuss and Act on Establishing Date, Time, Location and Call for a Special Town Meeting MOTION: Selectmen Grindle/ Chapel moved/ seconded to table the discussion until the end of the meeting. All in favor; motion passed.

E. Discuss General Budget

First Selectman Cahill stated that information from the state was starting to come in that afternoon, and estimated \$360,000 in lost revenue to the town from car property tax if that proposal passes legislation.

Selectmen discussed salary adjustments to highway department and administrative assistant positions. A schedule for budget workshops will be arranged.

F. Auditor's Report

First Selectman Cahill stated that the town was in good shape and had a 20% surplus in the general fund.

G. Discuss and Act on CCM Prescription Drug Card Program

Selectmen will have a representative to do a presentation to the board/ town.

MOTION: Selectmen Grindle/ Chapel moved/ seconded to table discussion. All in favor; motion passed.

H. Discuss Land Acquisition (possible executive session anticipated)

A piece of property contiguous to the Town Hall property (about 20 acres) will be going up for tax sale.

MOTION: Selectmen Grindle/ Chapel moved/ seconded to discuss the possible land acquisition in executive session. All in favor; motion passed.

Board of Selectmen went in to Executive Session at 7:34pm.

MOTION: Selectmen Chapel/ Grindle moved/ seconded to come back in to regular session from executive session. All in favor; motion passed.

Board of Selectmen resumed regular session at 7:43pm.

MOTION: Selectmen Chapel/ Grindle moved/ seconded to pursue the purchase, not to exceed \$75,000, of a portion of the Parrow property up to 20 acres. All in favor; motion passed.

D. Discuss and Act on Establishing Date, Time, Location and Call for a Special Town Meeting (tabled from earlier in the meeting)

MOTION: Selectmen Chapel/ Grindle moved/ seconded to move the following questions to a Special Town Meeting February 19, 2013 at 7PM in the Community Room of the Town Hall.

- 1. To hear discussion and act on the question of "Shall the Town of Hampton acquire a parcel of land approximately 51 acres currently owned by Michael D. Vadnais known as the Rita D. Edwards property for the sum of \$210,000 to be expended from the Town of Hampton's Capital Non-Recurring Open Space Fund and \$101,500 reimbursed through the State of Connecticut DEEP Grant".
- 2. To hear discussion and act on the question of "Shall the Town of Hampton transfer \$100,000 from the General Fund to Capital Non-Recurring Land Acquisition Fund for the purpose of purchasing two parcels up to 20 acres total, for up to \$75,000, from Ron Parrow".
- 3. To hear discussion and act on the question of "Shall the Town of Hampton transfer \$100,000 from the General Fund to Capital Non-Recurring Building Fund for the purpose of finishing improvements at the Town Hall".

All in favor; motion passed.

ITEM 12: Audience for Citizens

Vi Marquis asked about the school's financial requests, and it was determined that it has been addressed by the Board of Finance.
