1. **Call to order - Chairperson Rose Bisson called the meeting to order at 5:13 pm. Members present Maryellen Donnelly, Matthew Flegert, Susan Lovegreen, Russ Moffitt, Juan Arriola, Neal Moon and Ann Gruenberg at 5:17pm. Also, present Superintendent Frank Olah, Principal Sam Roberson and Business Coordinator Sally Lehoux.**
2. **Audience for Staff and Citizens - Terry Yaworski addressed the board concerning long distant learning. Dana McDermott questioned how parents could obtain information on long distance learning. Sam Roberson said that parents could contact her. Kathy Donahue spoke to limiting the time frame of motions till April 30, 2020.**
3. **Discuss and act on recommended MOA between BOE and HEA - Maryellen moved that the Board of Education enter into the Memorandum of Agreement with the HEA dated March 20, 2020. Ann Gruenberg seconded and the motion passed with the following vote:

5. **Discuss and act on recommended Paid Leave proposal - Maryellen Donnelly moved to grant paid leave to all hourly employees in an amount that, when added to actual hours worked, equals the number of hours the employee would have worked if the school was not shut down, based on the school calendar year. Juan Arriola seconded and the motion passed with the following vote:

Ann Gruenberg moved grant hazard pay to hourly employees in the amount of \$3 per hour for each hour they are required to work in the building. No one seconded motion failed.  
Maryellen Donnelly moved to grant one week of vacation time to executive secretary and custodian in consideration of their willingness to continue working when other hourly employees were not required to work. Matthew Flegert seconded and the motion passed with the following vote:
