**BOARD OF SELECTMEN MEETING MINUTES**

**April 5, 2021**

1. Call to Order – 7:00 PM
2. In Attendance – First Selectman Cahill, Selectman Grindle and Selectman Meade. Also in attendance John Guskowski who is hosting this meeting and First Selectman Cahill would like to thank him for hosting and helping us facilitate this meeting via gotomeeting
3. Audience for Citizens – Bruce Spaman would like to add to the agenda plan for Arbor Day April 30, 2021 at Hampton Elementary School. He has contacted Recreation Commission, Board of Education, PTO, Hampton Conservation Commission, Eversource and Big Y. He would like help with the plating from Town of Hampton. Mark Samios stated that the KB Ambulance contract went from \$50,600 to \$110,000 which is a large increase. He wanted to know if Ambulance contract going out to bid . First Selectman Cahill said he is going to meet with them tomorrow night and draft a contract. Increase of \$2000 (3% increase). He does not know details at this time but it will be a 1 year contract.

State \$25,000 grant plus our contribution.
