Hampton Board of Selectman Meeting Minutes

1. Call to Order - 7:01 PM

a. Members present – First Selectman Allan Cahill, Selectman Bob Grindle, Selectman John Tillinghast

2. Audience for Citizens

- a. Dayna McDermott
 - Referred to Republican Town Committee Chair, Juan Arriola, about his support to endorse Kathi Newcome into the Board of Finance as alternate
 - ii. Requested that the January 3rd Board of Selectmen meeting minutes be corrected as it states she was in attendance when she was not: "Dayna McDermott claimed someone took all the Gazette's in the display rack out and put them in the shredder box."
 - iii. Stated she thinks it would be beneficial to have The Hampton Gazette at least named on the town website since it is not linked
 - iv. Continued discussion from previous meeting about the comparison between Hampton and other towns having their newspapers linked on their town websites

 - First Selectman Cahill stated there were no significant findings and made motion to approve/Selectman Tillinghast moved/Selectman Grindle seconded. Unanimously passed.
- c. Review 2022-2023 budget draft
 - i. First Selectman stated Cahill stated there was a 3% increase in Tax Revenue Department
 - ii. Contract to sign will be put on next month's agenda

- iii. Overall energy increase is an unknown variable
- iv. Added to town attorney's line item
- v. Ambulance increased 30%
- vi. Small increase to Planning & Zoning
- vii. The Town's Health Insurance, Connecticare, has gone up 15%
- viii. Wants to pursue a mid duty truck to the Department of Public Works
- ix. Selectman Grindle stated the Memorial Day Committee can be left at \$450 seeing as so far they've used \$400
