Annual Town Meeting – June 20, 2025

The legal Voters and those qualified to vote in Town Meeting are hereby warned to assemble in a Town Meeting at the Hampton Town Hall, lower level, 164 Main Street Hampton, Connecticut on June 20, 2025 at 7:00 PM to transact the following business:

- 1. Call to order
- 2. To elect a moderator for said meeting.
- 3. To authorize the Board of Selectman to borrow, if necessary, money to defray expenses until other funds are available.
- 4. To nominate and elect one member to the Regional District 11 Board of Education for a term of 3 years, beginning with the first board meeting in July, 2025.
- 5. To authorize the Board of Selectmen to enter into agreement with Commissioner of the Connecticut Department of Transportation for the expenditure of funds for the fiscal year July 1, 2025 through June 30, 2026 for improvement and maintenance of Town roads.
- 6. To authorize the Board of Selectman to approve and accept Local Capital Improvement Funds (LOCIP) from the State of Connecticut for road improvement.
- 7. To approve the 5 year Capital Improvement Plan including the 5 year Road Plan.
- 8. To hear discussion and act on the General Budget for the year July 1, 2025 through June 30, 2026 as recommended by the Board of Finance, and to appropriate sums of money as required.
- To hear discussion and act on the Hampton Elementary School Budget for the year July 1, 2025 through June 30, 2026 as recommended by the Board of Finance, and to appropriate sums of money as required.
- 10. To hear discussion and act on the transfer of CNR unallocated funds to Trucks and Equipment.
- 11. To hear discussion and act on the appropriation of \$150,000 from the General Fund for the purchase of a Department of Public Works Tractor & Road Mower.
- 12. To hear discussion and act on the request to combine the Capital Building Fund—account 2400 with the Reserve Town Hall—account 2410-02.
- 13. To hear discussion and act on the transfer of \$27,400 from the Unassigned General Fund for a building and mechanical evaluation study of HES.
- 14. To hear discussion and act on the transfer of \$50,000 from the Unassigned General Fund for the Volunteer Firefighter Length of Service Program.

15. To hear discussion and act on the transfer of funds from the unassigned fund balance to cover 2024-2025 budget overages.

16. Adjournment

At its meeting held on June 2, 2025 the Board of Selectmen voted, pursuant to Section 7-7 of the Connecticut General Statutes, that items 8, 9, 10, 11, 13, and 14 on the call of the June 20, 2025 Annual Town Meeting be submitted to referendum vote on June 27, 2025 between the hours of Noon and 8:00 PM at the Town Hall, 164 Main Street, Hampton, CT.

The designation of the questions on the ballot for said referendum vote shall be as follows:

- 1. "Shall the Town of Hampton appropriate \$1,949,439 for General Government for the 2025-2026 fiscal year?"
- 2. "Shall the Town of Hampton appropriate \$2,262,603 for the Hampton Elementary School for the 2025-2026 fiscal year?"
- 3. "Shall the Town of Hampton transfer Account 2450 in the Capital Nonrecurring Fund of unallocated funds to Account 2430 Trucks and Equipment?"
- 4. "Shall the Town of Hampton approve the transfer of \$150,000 from the Unassigned General Fund to the Capital Nonrecurring 2430 trucks and equipment for the purchase of a Department of Public Works Tractor & Road Mower?"
- 5. "Shall the Town of Hampton approve the expense of \$27,400 from the Unassigned General Fund for a Building and Mechanical Evaluation Study of Hampton Elementary School, as required by CGS \$10-220?"
- 6. "Shall the Town of Hampton approve the transfer of \$50,000 from the Unassigned General Fund Balance for the Volunteer Firefighter Length of Service Program?"
