Annual Town Meeting – June 20, 2024

The legal Voters and those qualified to vote in Town Meeting are hereby warned to assemble in a Town Meeting at the Hampton Town Hall, lower level, 164 Main Street Hampton, Connecticut on June 20, 2024 at 7:00 PM to transact the following business:

1. Call to order
2. To elect a moderator for said meeting.
3. To authorize the Board of Selectman to borrow, if necessary, money to defray expenses until other funds are available.
4. To nominate and elect one member to the Regional District 11 Board of Education for a term of 3 years, beginning with the first board meeting in July, 2024.
5. To authorize the Board of Selectmen to enter into agreement with Commissioner of the Connecticut Department of Transportation for the expenditure of funds for the fiscal year July 1, 2024 through June 30, 2025 for improvement and maintenance of Town roads.
6. To authorize the Board of Selectman to approve and accept Local Capital Improvement Funds (LOCIP) from the State of Connecticut for road improvement.
7. To approve the 5 year Capital Improvement Plan including the 5 year Road Plan.
8. To hear discussion and act on the General Budget for the year July 1, 2024 through June 30, 2025 as recommended by the Board of Finance, and to appropriate sums of money as required.
9. To hear discussion and act on the Hampton Elementary School Budget for the year July 1, 2024 through June 30, 2025 as recommended by the Board of Finance, and to appropriate sums of money as required.
10. To hear discussion and act on the transfer of CNR unallocated funds to the Capital Building Fund.
11. To hear discussion and act on whether the town should support and act as liaison for the Trail Woods Neighborhood Assistance Act.
12. To hear discussion and act on the appropriation of \$30,000 from the General Fund for the purchase of a Department of Public Works pickup truck.
13. To hear discussion and act on the appropriation of \$40,000 from the General Fund to fund the oil tank removal and hot water propane upgrade at Hampton Elementary School.
14. Adjournment

At its meeting held on June 5, 2024 the Board of Selectmen voted, pursuant to Section 7-7 of the Connecticut General Statutes, that items 8, 9, 10, 11, 12, and 13 on the call of the June 20, 2024 Annual Town Meeting be submitted to referendum vote on June 27, 2024 between the hours of Noon and 8:00 PM at the Town Hall, 164 Main Street, Hampton, CT.

The designation of the questions on the ballot for said referendum vote shall be as follows:

1. "Shall the Town of Hampton appropriate \$1,889,541 for General Government for the 2024-2025 fiscal year?"
2. "Shall the Town of Hampton appropriate \$2,179,600 for the Hampton Elementary School for the 2024-2025 fiscal year?"
3. "Shall the Town of Hampton transfer Account 2450 in the Capital Nonrecurring Fund of unallocated funds to Account 2400 Capital Building Fund?"
4. "Shall the Town of Hampton support and act as liaison for the Trail Woods Neighborhood Assistance Act?"
5. "Shall the Town of Hampton approve the transfer of \$30,000 from the Unassigned General Fund to the Capital Nonrecurring 2430 trucks and equipment for the purchase of a Department of Public Works pickup truck?"
6. "Shall the Town of Hampton approve the transfer of \$40,000 from the Unassigned General Fund to the Capital Nonrecurring 2445 School Capital Fund to fund the oil tank removal and hot water propane upgrade for Hampton Elementary School?"
