 Rose Bisson called the meeting to order at 7:01 pm.
- 2. Audience for Citizens No commentary.
- 3. Committee Reports and Discussion

Costs - John Burnham reported the committee has heard back from four towns. The figures came back in different formats and need to be organized. John will share electronic copies with the board chairs and they will disseminate the information to their board members. The group discussed the need for individual elementary boards to discuss the program that they would provide for seventh and eighth graders if those grades were placed into the elementary boards' programs. The group also discussed requesting Eastconn provide a workshop for small districts to discuss common issues.

The Scotland Board of Selectmen voted not to release the funds unless it was to a study committee formed to study either dissolution of Regional District 11 or a study of addition/withdrawal of grades to Regional District 11.

The Hampton and Scotland Boards of Education agreed to include an item on the agenda of the next meeting to discuss and possibly act on this topic.
