## CHILDREN AND FAMILIES

- Ice skating (winter 2012-13) - conclusion that this venture needs to be part of a larger longer-term town discussion and planning project about uses for Town Hall/CCenter property
- Christmas tree disposal gathering (bonfire), perhaps with associated skating facility at transfer station (bonfire), January, $2013 \$ 5$ per tree, Marc Ayotte to lead
- Tellabration (fall 2012) - Juan to research bringing graduate students from the Graduate Institute to present.
- Discuss and act on request to Town for funding for FY 2012-13
- Juan also suggested retaining Joseph Firecrow, a Native American storyteller, flutist, and drummer, date TBD
- Forks not Knives - film and presentation on vegetarianism (late May 2013)
- Fat, Sick and Nearly Dead (late March 2013) - film and presentation on organic juices

- Consider a play reading and a DJ street dance for MemDay afternoon and evening
- Consider an art exhibit of local artists' and children's art work in upper level for Mem. day
