## MONDAY OCTOBER 22, 2018 7:00 PM REGULAR MEETING

- 1. Called to Order Chairman Kevin Grindle called the meeting to order at 7:03 pm.
- 2. Roll Call/Seating of Alternate Members In attendance were PZC members Everett Hyde, Susan Hochstetter, and Gloria Langer. Alternate Stan Crawford was seated for Gary DeCesare. Also in attendance were staff John Guszkowski and intern Michael Lucas.
- Presentation and Public Forum: Village Districts, Historic Districts, Design Standards & Economic **Development** – Michael Lucas provided the Commission with a brief presentation on village districts, historic districts, design standards and economic development. The Commission had an open discussion with Town residents about the presentation that was given. In the discussion the following concerns and ideas were expressed; concerns on the possible redistricting of Main Street, adding a village district to Route 6, traffic on Main Street, the number of properties that would be affected, the relationship between commercial development and historic preservation, design control, and the preservation of a small-town village. Gay Wagner addressed the board with her concerns on the possible redistricting of the Main Street section of Hampton, and provided recommendations on a possible village district on Route 6. Ann Gruenberg addressed the Commission about the traffic on Main Street. A resident asked about the number of properties this would affect. Bob Burgoyne addressed the Commission about economic development and historic districts. Bob Petix spoke to the Commission about the purpose of the presentation that was given. Laura Petix spoke to the Commission about the presentation that was given and retail uses. Richard Prario spoke to the Commission about design control and the speeding traffic on Main Street. Marny Lawton spoke to the Commission about marketing the historical character of Main Street. The resident of 210 Main Street spoke to the Commission about the small-town village feeling. Angelica Hansen spoke to the Commission about the general store and the uncertainty of its future. Everett Hyde discussed the economic challenges of historic preservation and the opportunities of historic tax credits. Chairman Grindle re-framed the discussion and assured the public that the Commission was interested in their input and the process and had not pre-ordained a direction for this investigation.
