# TOWN OF HAMPTON Planning and Zoning Commission Public Hearing & Regular Meeting Minutes January 25, 2016

## **Public Hearing**

# **1.** Application for a special permit to operate a package liquor store at 396 Hartford Turnpike/Business Zone; Pankaj Patel, owner/applicant, B Zone.

Chair Grindle called the public hearing to order at 7:05 p.m. Bob DeLuca, of CLA Engineers, presented updated plans on behalf of Mr. Patel. The Commission was also presented with comments from the fire marshal, an approval letter from DOT, proposed sign lighting fixture samples, and proposed building lighting fixture samples.

Mr. DeLuca and the Commission discussed additional items including fencing, landscaping, dark sky compliance, free-standing sign placement, wall signage and wetlands soils. Both parties agreed to infiltrate as much stormwater onsite as possible without causing a monetary burden to the owner. Using a drywell or a CL catchbasin with holes and crushed stone around would accomplish this goal; Mr. Deluca will expand on the concept and produce the engineering details to Fraenkel.

Chair Grindle opened the hearing to testimony in favor of the application. Selectman Mike Chapel, neighbor Gregg Freiman and resident Bruce Kinzer spoke in favor of the application. There were no additional comments.

**MOTION**: DeCesare/Hyde moved/seconded to close the public hearing. All in favor; motion passed. The public hearing closed at 8:00 p.m.

5. Lighting fixture details will be approved by staff prior to installation.

6. Prior to recording of the plan in the Land Records, infiltration details will be approved by staff.
