PUBLIC HEARING

- 1. Call to Order Chairman Kevin Grindle called the public hearing to order at 7:00pm.
- Roll Call/ Seating of Alternate Members In attendance were PZC members Gary DeCesare, Everett Hyde, Susan Hochstetter, and Gloria Langer. Also, in attendance were alternates Stanley Crawford, Jamie Boss and staff John Guszkowski.
- 3. Public Hearing
 - a. Special Permit Application: Standard Restaurant at 258 Main Street. Applicant James Saylor Chairman Kevin Grindle informed the Commission that the public hearing was advertised in the Willimantic Chronicle on July 12, 2018 and July 19, 2018. John Guszkowski informed the Commission that the applicant asked that the public hearing be extended. Everett Hyde moved to extend the Public Hearing to the August 27, 2018 meeting. Gary DeCesare seconded and the motion passed unanimously.
 - b. Subdivision Applicant: 1 Lot Resubdivision on Rogers Road/South Brook Road. Applicant Steve & Kathy Donahue Chairman Kevin Grindle informed the Commission that the public hearing was advertised in the Willimantic Chronicle on July 12, 2018 and July 19, 2018. Steven Donahue provided the Commission with a copy of the letter sent to abutters, the receipts of certified mail to abutters and the inland wetlands permit. John Guszkowski question whether the subdivision be traditional subdivision or conservation subdivision design. Steven Donahue noted that the subdivision would be a "family transfer" split, and John Guszkowski stated that if this was verified by a notarized affidavit, the subdivision would not be subject to a conservation or open space set-aside. David Fowler from South Brook Road questioned the location of the property. Gary DeCesare moved to close the Public Hearing. Everett Hyde seconded and the motion passed unanimously.
 - c. Zoning Amendment Application: New Application New Section 4.2.P "Ground Mounted Solar Arrays." Applicant Hampton PZC Chairman Kevin Grindle informed the Commission that the public hearing was advertised in the Willimantic Chronicle on July 12, 2018 and July 19, 2018. Susan Hochstetter shared her concerns with the proposed zoning amendments and felt that the Public Hearing should be left open so that new wording could be developed for the zoning amendment. Kate Donnelly read a letter from the Hampton Green Energy Committee speaking to the proposed zoning amendments and their agreement with the amendments. Gary DeCesare noted several areas of concern based on proposed regulations in the Town of Brooklyn, including height, coverage, materials/finish, deconstruction requirement, screening, and glare. Kathy Donahue asked about the proposed amendments and if there is limits to the size of the solar panels. Roger Dion spoke to the Commission to the adjustability of ground mounted solar panels. Everett Hyde moved to close the Public Hearing. Gloria Langer seconded and the motion failed with the following vote:
