Mr. Ford stated that the structure was found to be not strong enough to support the solar panels.

DeCesare stated that as he remembered, the manufacturer would not guarantee the roof if holes were drilled to install solar panels.

Hyde discussed the proposed plan and timeline and Chair Grindle suggested that PZC should be involved at the end of the conversation, as what the project looked like would be determined by the community before it comes before PZC to determine if the plan meets PZC regulations.
