He spoke of a feature on NBC CT News about Joe’s project and how proud he is of Joe’s accomplishments. Joe’s goal is to one day have Blind Baseball registered as an official sport in the Paralympics.**

- 6. Administrative Reports/Administrative Requests for Board Action**

**A. Principal –** Principal Brian Tedeschi updated the Board on the High School Choice Visitation, Senior Joe Landolphi’s Capstone Project on Baseball with the Blind, Lexi Smardon’s Capstone Project about a 5K race she’s holding for Veteran Suicide Prevention and Awareness on October 24<sup>th</sup>, The Night of the Arts to be held on October 27<sup>th</sup>, the Parish Hill Trunk or Treat Event planned for October 28<sup>th</sup>, the November 12<sup>th</sup> PD Day and the NEASC’s acceptance of Parish Hill’s 5-year plan.

**B. Superintendent –** Superintendent Ken Henrici spoke to the Board about the Enrollment Report, his CAPSS meeting regarding COVID protocols, budgets and “poaching” staff from other Districts at higher salaries, the Teacher Negotiations, the Parish Hill/Chaplin Principal’s meeting, the 2022-2023 School Calendar plans, the proposed new Director of Special Education, the Website meeting, the Governor’s Executive Order and being in 100% compliance, the attendance at the September &

October vaccination clinics and plans to hold future clinics every 3 weeks for the next few months, the expulsion hearing to be held next Monday and the Veterans' Luncheon to be held on November 10<sup>th</sup>. He also congratulated Joe Landolphi and Lexi Smardon on their wonderful Capstone Projects.

- B. Report by PHACT/PTSA – Michael Smardon reported on behalf of Sherry Smardon this evening. He spoke about the Savers Fundraiser and the need to increase membership in the PHACT/PTSA. Their next meeting is October 21<sup>st</sup> at 6:00 pm.**
- C. American Rescue Plan – ESSER III Grant – Principal Tedeschi said the initial application was submitted, but was returned back with a request to provide some additional information. He is working on making the requested corrections.**
- D. Report on Vaccine Clinics – September 14 and October 5 – Superintendent Henrici reported that 18 people received shots on September 14<sup>th</sup> and 7 received shots at the October 5<sup>th</sup> clinic. He said we could have marketed the clinics better and plan to do so for future clinics.**
- E. Status Report on First Month of School – Superintendent Henrici said the first month of school went very well. Principal Tedeschi agreed and said it went far smoother than anticipated especially with COVID. It was a very positive opening.**
- F. Flexibilities for Educator Evaluation and Support Plan for 21-22 – Superintendent Henrici said that flexibility was requested and was granted. We will set our goals at the next PD Day and will focus on mental health of students and staff.**
