

When will you be receiving your tax bills?

If the Town of Hampton has an approved budget prior to June 15, 2020...Real Estate tax bills have 2 installments which will be mailed out the last week of June 2020 with a due date of July 1, 2020 and January 1, 2021. Motor Vehicle and Personal Property tax bills have 1 installment due July 1, 2020. All July installments must be received or postmarked by August 3, 2020 to avoid interest. The second installment will be due on January 1, 2021 and must be received or postmarked by February 1, 2021 to avoid interest.

You can come in o our office at 979 Main Street, Willimantic, CT to pay in person. Acceptable forms of payment are cash, checks, Mastercard, Visa, and Discover. There is a small vendor fee for the use of a credit or debit card. **All checks should be payable to Town of Hampton.** *Should you receive a parking ticket while paying your taxes, please contact our office.*

Credit/Debit-Card payment can be accepted over the phone with the same vendor fee. 860-465-3029.

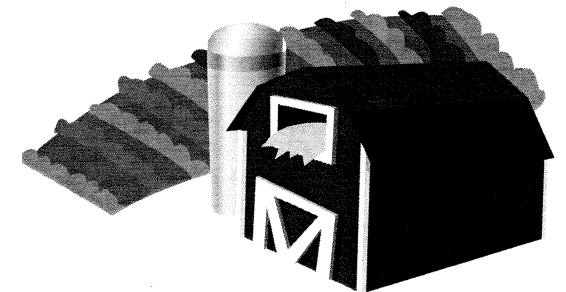
HAMPTON COMMUNITY CENTER

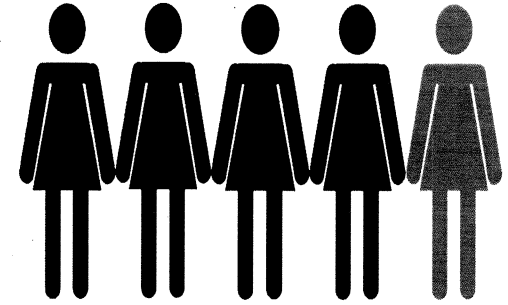
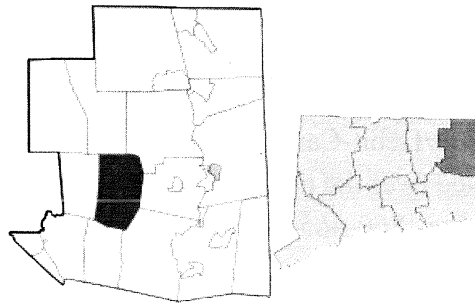
