# **ByLaws Review**

DeCesare seconded. Unanimously approved.

Special Meeting of 11/4/10: Langer moved to approve the minutes as submitted. Burgoyne seconded. The minutes were approved with Burgoyne and Langer in favor, Grindle, DeCesare and DeCarli abstained.

Chairman Grindle reordered the agenda.

Burgoyne moved to approve the proposed meeting schedule. DeCesare seconded. Unanimously approved.

# **Report from Zoning Official**

Fraenkel reported on an enforcement case on Sarah Pearl Road, Soucy property.

She noted that she was working on 3 separate queries regarding the status of old roads with regard to development and access to properties. Discussion followed, with no action taken.

#### **Old Business**

1. <u>Discussion: Zoning Regulations Revisions</u>

Discussion resumed on Conditional Uses in the RA-80 Zone.

Members discussed the possible exclusion of senior housing as a permitted use in the RA80 Zone. It was suggested that if senior housing is included in the regulations, there should be a minimum of 80,000 s.f. per unit. Concern was expressed for impact of lighting on the neighborhood. Discussion followed on the acceptability of this use in the RA-80 Zone.

Burgoyne moved to remove senior housing from the draft zoning regulations. DeCesare seconded. DeCesare, Burgoyne and DeCarli were in favor, with Langer and Grindle opposed. The motion was approved; senior housing will be removed from the draft revised regulations.

Burgoyne noted that this use could be reconsidered at a future date for reinsertion into the zoning regulations.

Members then considered tearooms in the RA-80 zone. There was interest in creating two sets of regulations to permit two different intensities of this activity: one that could permit daily operation and a second category to allow occasional activity, only, the latter with more relaxed standards with regard to buffers. Members agreed to draft the regulations to allow both intensities of use for tearooms, with the less intensive use permitted as a home business for up to 6 teas per year.

A special meeting was set for 12/16/10 at 7:30pm.

Noting no further business, the meeting was adjourned at 9:05pm.
