Motion: Selectman Grindle/Selectman Meade moved/seconded to approve the Hampton Elementary School lighting contract. Motion passed unanimously.

- D. Discussion & Action: Plaque at Community Center in recognition of the Pearl Family. Selectman Grindle asked to bring design for plaque for approval of the Board of Selectman and bring up next month meeting.
- 15. Audience for Citizens –Selectman Grindle seniors have \$8000 in budget and are asking for \$4,000 including \$1900 for kitchen supplies. Stan Crawford request you check as they had \$8,000 and nothing has been done. They are asking for \$1,900 for kitchen. There is no kitchen. Why pile up money. Will bring to Board of Finance.
