# a. Plan for meeting with other area towns.

# b. Status of HES roof project and DCS

DCS project coordinator, Peter Spinella, came to Hampton to site the system for the Town Garage and viewed the roof plans and roof at HES. Though asphalt tile is planned for the new roof, the underlying structure of the roof is metal and DCS does not install on metal roofs. The site does not lend to a ground mounted PV system. If the orientation is appropriate for a roof mounted PV system, the architectural firm may be contacted to determine if any modification of the roof plans is feasible and cost effective in order to anchor into wood.

# c. Town Garage Solar PV, DCS, mounting and location of array.

DCS project coordinator, Peter Spinella, met with HGEC members May 26 to site a photovoltaic ground array. Agenda for June 9 Planning and Zoning meeting includes approval and siting of an array. Monitoring

HGEC Minutes 6/1/2011 p. 1 of 2 systems will be installed on the Fire Station and Town Hall systems that will enable monitoring by computer.

# d. Report of inservice at HES about classroom use of monitoring solar thermal system

Rachel Butterfield, Wendy Timberman and Sue Moshier attended a two hour inservice provided by HGEC member Frank Russell. Frank will be available to follow up on classroom projects using data from the solar thermal system that are planned for next year
